

Table 1: Number of Registrants in the General and Extended Classes and Monthly Changes at the Start of Each Month

The following table shows the number of registrants holding active registration in the General and Extended Class at the start of each month, beginning in January 2020 and ending in January 2024. The table includes monthly additions, monthly losses, and monthly net changes.

Monthly Additions: A registration addition is a registrant who held active registration in the General or Extended Class in a particular month but did not hold active registration in the General or Extended Class in the prior month.

Monthly Losses: A registration loss is a registrant who did not hold active registration in the General or Extended Class in a particular month but held active General or Extended class registration in the prior month.

Net Change: The net change is calculated by subtracting the number of monthly losses from the number of monthly additions at the beginning of the month. This represents the overall change in the number of nurses holding active registration month-over-month.
